### **Hearings:**

#### **IV-1: Elite Club Enterprises, Inc. dba Riviera Show Club, 241 Southbridge Street-Rules #14, #29 – Manager violation, disturbance of the peace**

Attorney Carolyn O'Connell and Miril Muska appeared to answer to the violation.

Lt. Johnson presented the following:

On August 4, 2018 at 1:22 a.m. Officer Patrick Harrington was assigned to the Alcohol Enforcement Unit when he received a call to have officers respond to the Rivera Show Club for a fight.

Officer Harrington upon arrival observed police officers trying to disperse a large crowd and was informed that one of the victims involved in the fight was a pregnant female who received a laceration.

Officer Harrington spoke with other officers at the scene who informed him that the fight had initially started inside the Club and staff and security from the Club separated the aggressors and told them to leave. One of the victims expressed to staff that she wanted to call the police and press charges. Staff and security told her that police would be outside if she wanted to report it.

Officer Harrington spoke with two security personnel and the manager, Miril Muska, and asked why they had not called or reported that fight as required by the City of Worcester rules and regulations. Mr. Muska told Officer Harrington that he did not know he had too.

Attorney O'Connell stated that there was an incident inside the premises and security was notified immediately and handled the situation. Since there was a route officer outside security told the woman to go speak with the officer rather than calling 911.

Chair Salvidio asked if there was police outside. Lt. Johnson stated yes but the manager should have notified the police of the incident.

Attorney O'Connell stated that if the police were outside that was notifying the police.

Mr. Muska stated that for the past two months they have not been able to get police details so the route officers are outside to help when the crowd gets outside, so they told the girl to go speak with the officers already outside.

Chair Salvidio stated that he believes the Rivera Show Club did what was required.

Upon a motion the Commission voted 3-0 that that violation did not occur.
