        - Increase cost of **Project #606075** – OXFORD – CLEANING AND PAINTING & RELATED WORK, O-06-036 I-395 OVER DANA ROAD AND O-06-037, I-395 (SB) OVER FEDERAL HILL ROAD. Current project cost is \$1,519,966 from Bridge Maintenance funding. New project cost will be \$2,837,253; \$1,626,441 in Bridge Maintenance funding and \$1,210,812 in NFA Bridge funding. Project description will also change by adding O-06-032, CUDWORTH ROAD OVER I-395 NORTHBOUND AND SOUTHBOUND.
