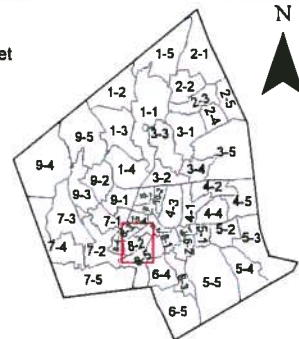

Early Voting 2016

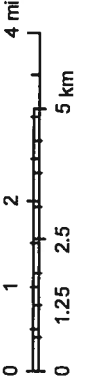
