#### **New Business**


- Poll Worker Training for the 9/10 /2019 Preliminary Election is scheduled. There are
  three training sessions scheduled for those assigned to work at polling locations.
  Precinct wardens and clerks will have training sessions that are separate from the
  training offered to inspectors. The training will cover how poll workers should deal with
  inactive voters, voters who are no registered at the location, any issues concerning the
  auto mark, and how to open and close polls.
- 2. There will be iPad's at every location and polling staff (wardens and clerks) will be trained on all new technology. Vendors will come to download the new software. The iPads are not approved as a means to check-in voters. At this time, the iPads are to be used to lookup voters. Staff at polling locations must continue to use the traditional means for check-ins. There will be 50 wardens and 50 clerks working on election day.
- 3. The Ascentria language bank will be used on election day and reportedly functions 24 hours per day. Should a voter require translation services, the poll workers will direct the voter to the warden or clerk who will have access to a cell phone and use of the language bank.
- 4. In terms of efforts to increase voter turnout, a public service announcement video has been recorded and was viewed by the Board. The video will be shown on Charter TV, and the city's social media accounts. Additionally, the video will be available on the city's website.
- 5. There was a discussion about inactive voters and Assistant Clerk Vangjeli reported that there has been some improvement. However, the city is not where it would like to be in terms of improvement, according to Assistant Clerk Vangjeli. Reportedly, Worcester State Representative David LeBeouf (17<sup>th</sup> Worcester) is in the early stages of sponsoring a bill that would allow cities to deactivate voter every two years as opposed to every year. The bill, should it become law would ensure congruency between the laws

affecting active and inactive voters. It was reported that the voters are registered via the RMV and voter registration will become automated in the near future. Additionally, there are discussions regarding automatic voter registration via social service agencies such as Masshealth and the Department of Transitional Assistance.

6. The next meeting of the Board will involve a drawing of the ballot order for the November 5<sup>th</sup> election.
