1. Call to Order:

There being a quorum the Chair called the meeting to order at 6:03pm.

2. Introductions:

(a) Bi Annual E. Hawley Award: Report from Subcommittee

(c) Foreclosure Complaint Response

There was a discussion about the Commission's response to the WAFT complaint. Jayna Turchek notified the Commission that she mailed a meeting notice for today's meeting to WAFT. No one from WAFT was present at the meeting.

Eduardo Rivera proposed organizing an educational effort to address some of the concerns in WAFT's complaint and it was tabled. There was a discussion about a possible review of the Commission's ordinance which was also tabled.

A motion was made and carried to have the Office of Human Rights communicate though a correspondence and explain position of the Commission based on the City Solicitor's feedback. The communication will be sent to WAFT post haste.

(d) Know Your Rights / Voting Rights

The Know Your Rights event will take place on Monday October 1st at the Worcester Senior Center, 128 Providence St. Panelists are confirmed, the event has been publicized, and preparations are in order. Commission members were asked to select tasks for the evening. Eduardo Rivera will welcome the panelists and audience, Cara will moderate the Q&A session for the first panel and Mable will moderate the second panel. Kathy and Edward Robinson will be official greeters at the door. Ed Robinson will facilitate the use of the audience microphone for Q&A. Udeme will be the timekeeper for the first panel and Harry timekeeper for the second panel. All members are requested to wear/bring their Commission nametags and arrive early.

(e) Worcester Pride Day

Edward Robinson reported on Worcester PRIDE day. He walked in the parade as a representative from the Commission and later tabled the event. There was a great turnout and it was a fun day. The only concern from the community was that the T&G published a controversial picture.



About Thurgood Marshall

The first Black Supreme Court Justice, Thurgood Marshall made a name for himself defending critical cases in the history of human and civil rights like Brown v. Board of Education. In addition to that landmark decision, overturning the previous declaime of "separate but equal," he also worked on individual cases to help Black students gain their rightful access to education, including Autherine Lucy (below) at the University of Alabama in 1956.

About the Bill of Rights and other Constitutional amendments, Thurgood Marshall said, "Today's Constitution is a realistic document of freedom only because of several corrective amendments." This tells us that our nation is only made stronger when we question and challenge ways that it may, from time to time, fail to live up to its principles. On December 10, 2012, the Human Rights Commission will celebrate our ongoing work to expand and enforce Human Rights for all of Worcester.

The following report is prepared for the Human Rights Commission detailing the case flow of the Bureau of Professional Standards for the second quarter of calendar year 2012, for the period April 1, 2012 through July 1, 2012. The data presented in this report are simply rote numbers gleaned from the individual cases received during the second quarter

The Bureau of Professional Standards received a total of 13 individual complaints for investigation, from sources both internal and external to this department during this period of time. Each of these 13 individual complaints was assigned to one or more police officials assigned to the Bureau of Professional Standards.

Further analysis of the 13 complaints received, reflects a total of 28 separate allegations which were received according to the following most frequent occurrences:
