#### 5. Old Business:

#### a) Mediation Video

Commission members will find actors to perform the video in English, Spanish, Vietnamese and Twi. The taping of the videos will be in August and members will assist with the editing process. The Commission emphasized that this project demonstrated their interest and commitment to use mediation to solve local disputes.

## b) Annual Report of the Commission

The Chair motioned to move this item to the August 5<sup>th</sup> Meeting. Motion unanimously passed.

### c) Quarterly planning

Commission activities for the July-September quarter will include: the Community Reading for the Anniversary of Dr. King's "I Have a Dream" speech, a LGBTQ resource guide, the Mediation Video, and the PRIDE parade and celebration.

The Commission plans to draft a Human Rights calendar that will identify signature Human Rights events for the August 5<sup>th</sup> meeting.

Quarter (October-December): Commission added Human Rights day celebration to Quarterly Calendar.

d) <u>The Anniversary of Dr. King's "I Have a Dream" speech (August 28<sup>th</sup>, 2013)</u> The Commission is organizing an event from 12:00-1:00PM in the Worcester Common to celebrate the 150<sup>th</sup> Anniversary of the Emancipation Proclamation and the 50<sup>th</sup> Anniversary of Dr. King's "I Have a Dream" speech. Jeremy Fontain volunteered to assist with the coordination and planning for the event.

#### e) LGBTQ education and awareness

The Commission is working to create an LGBTQ resource guide. A draft is expected to be prepared for the August  $5^{th}$ , 2013 meeting.
