REGULAR MEETING (10:00 AM)

CALL TO ORDER:

Chairman Lukes called the meeting to order at 10:00 a.m.

MINUTES:

Upon a motion by Chairman Lukes and seconded by Commissioner Shea the Commission voted 3-0 to approve the minutes of October 13, 2011.

UNFINISHED BUSINESS:

1. 55 Pearl Street - FZ Management LLC dba Sushi Rock, Joshua Head & Frank Zirpolo

Petition: Request for common victualer all alcoholic license Application withdrawn by applicant

2. 27 Pleasant Street - International Lounge - Andre Mihael & Roland Georges

Petition: Request to amend condition of liquor license to allow under 21 in establishment between 10:00 a.m. & 10:00 p.m.

Andre Mikhael appeared on behalf of application. Mr. Mikhael stated he wanted to open establishment for 18+ during the week for food, non-alcoholic drinks and internet usage.

Upon a motion by Chairman Lukes and seconded by Commissioner Shea the Commission voted 3-0 to approve allowing establishment to be open to 18+ seven days a week between the hours of 10:00 a.m. and 8:00 p.m. After 8:00 p.m. establishment is 21 years of age or older only.

As Mr. Marca could not answer the questions presented to him by the Commission it was suggested he meet with Lt. Johnson prior to the next scheduled License Commission meeting to clearly outline the event.

PUBLIC HEARINGS

11. 1140 Grafton Street – Ishwar Kurpa Inc. dba YD Liquors

Violation of Rule #6, #21, MGL c. 138. §34

Ishwar Kurpa, manager of YD Liquors was present to respond to violation. Lt. Johnson presented the following report:

The undersigned Alcohol Enforcement Officer requests that the License Commission notify YD Liquors (1140 Grafton St.) to appear before the License Commission to answer police complaints of violating rule # 6 and rule # 21 of the Rules and Regulations of the License Commission for Alcoholic Beverages NOT CONSUMED on the Premises on August 8, 2011.

Rule # 6: "Sales TO persons under 21 are punishable by fine or imprisonment or both. (Chapter 138 Section 34)."

Rule # 21: "Managers of all licensed liquor establishments shall be responsible for all violations or infractions of the law occurring on the premises whether present or not. The licensee is responsible for any disorder, disturbance or illegality of any kind taking place on license premises whether present or not."

On August 8, 2011 the undersigned Alcohol Enforcement Unit Officer, along with P.O. Patrick Harrington, conducted an underage drinking sting in which a 19 year old male (identifying information kept in the Alcohol Unit) attempted to purchase alcohol at various package stores throughout the City of Worcester from around 1100 hrs to 1530 hrs. The underage male was given a breathalyzer test prior to the start and at the end of the mission. He was instructed, prior to entering each establishment that he was to attempt to purchase a six pack of Bud Light and to not offer any identification. He was instructed that if he were asked to provide identification to politely state that he didn't have any and to walk out of the POB. The underage male, in fact, had no identification on him. He was also instructed, in the event that he was able to purchase the beer, to walk calmly and casually out of the POB with the purchase where he would be met by the Officer(s), preferably out of view of the POB. The underage male was given these instructions prior to entering each establishment.

The underage male entered YD Liquors (1140 Grafton St.) on the above date at around 1425 hrs. and did purchase a six pack of Bud Light for \$6.25 without being asked to provide identification. The underage male turned the beer over to P.O. Harrington and it was stored in Evidence at the Alcohol Unit.

The undersigned notified the only employee seen on the premises that they had sold to an underage male and that the POB would be brought before the License Commission to answer complaints.

Mr. Patel admitted to the facts as presented.

The Commission members reviewed the case file for YD Liquors and the establishment had similar violation in 2010.

The Commission voted 3-0 on a roll call that establishment would receive a three day suspended suspension.

12. 107 Ward Street - R.S.L. Enterprises dba Harraghy's Package Store

Violation of Rules #6, #21, MGL c. 138 §34

Robert Largess appeared to answer to the violations

Lt. James Johnson presented the following report:

The undersigned Alcohol Enforcement Officer requests that the License Commission notify Harraghy's Package Store (107 Ward St.) to appear before the License Commission to answer police complaints of violating rule # 6 and rule # 21 of the Rules and Regulations of the License Commission for Alcoholic Beverages NOT CONSUMED on the Premises on August 8, 2011.

Rule # 6: "Sales TO persons under 21 are punishable by fine or imprisonment or both. (Chapter 138 Section 34)."

Rule # 21: "Managers of all licensed liquor establishments shall be responsible for all violations or infractions of the law occurring on the premises whether present or not. The licensee is responsible for any disorder, disturbance or illegality of any kind taking place on license premises whether present or not."

The undersigned notified the only employee seen on the premises that they had sold to an underage male and that the POB would be brought before the License Commission to answer complaints.

Mr. Largess admitted to the facts as presented.

The Commission members reviewed the case file and found no previous violations at location.

The Commission voted 3-0 on a roll call that violation had occurred. The Commission voted 3-0 on a roll call that establishment should be given a warning.

13. 278 Millbury Street - Millizan Inc. dba Millbury Street Liquors

Violation of Rules #6, #21, MGL C 138, § 34

The owner of establishment had requested continuance due to medical appointment.

14. 18 Grafton Street - SSBY LLC

Violation of MGL c. 138, § 77

Ms. Steele explained that license had been seized by DOR in August and establishment had closed and never re-opened.

The Commission voted 3-0 to rescind the liquor license for 18 Grafton Street – SSBY LLC for cessation of business.
