Call to Order

Approval of the Minutes – 3/28/2013, 12/19/2013

New Business

One Day Liquor & Entertainment Requests:

1. Petition: Request for one day liquor license – January 25, 2014-6:00 p.m.-Midnight

Petitioner: St. Spyridon Cathedral – 102 Russell Street

Upon a motion by Commissioner Salvidio the Commission voted 3-0 to approve the one day liquor license for St. Spyridon Cathedral.

7. Petition: Request for change of manager & change officers & directors

9. Petitioner: Green Diamond, LLC dba Worcester Bravehearts, Fitton Field-1 College Street

John Creedon appeared on behalf of the application.

Chair Shea stated that herself and the other Commissioners had viewed the site prior to the meeting.

Mr. Creedon stated that this will be for the alcohol concession for the new Worcester Braveheart baseball team that will start in Spring 2014.

Commissioner Mullan asked how much hard alcohol was going to be sold. Mr. Creedon stated it will mostly beer and wine and only hard alcohol will be sold on special promotional nights they may have.

Lt. Johnson stated he would like to see a police detail for the first few games just so everything goes smoothly. Mr. Creedon stated he would be amenable to that.

Upon a motion by Commissioner Salvidio the Commission voted 3-0 to approve the general on premises all alcohol license for Green Diamond LLC dba Worcester Bravehearts.

10. Petition: Request for new restaurant all alcohol license

Petitioner: Chongquing Corporation dba Red Pepper Restaurant, 1083 Main Street

Alan Wong appeared on behalf of the application. He stated he will be opening a new restaurant at this location and would like to sell alcohol. Mr. Wong stated he also has another restaurant that sells alcohol so has experience on the way things need to be run.

Upon a motion by Commissioner Salvdio the Commission voted 3-0 to approve the restaurant all alcohol license for Chongquing Corporation dba Red Pepper Restaurant.

Violation Hearings

11. The Shisha Room, 86 Shrewsbury Street – Violation of Rules #1, #14,

Rosemarie Melkonian appeared to answer to the violation and waived her right to counsel.

Lt. Johnson presented the following:

On October 25, 2013, Officer Edward Saucier was on patrol in the Shrewsbury Street area and at 2:15 a.m. noticed a group of four people sitting at a table inside the Shisha Room. Officer Saucier proceeded to enter the establishment and observed the four people sitting at the table. Two of the patrons had half full Corona Beer bottles. The only other people in the establishment at the time of the incident were the bartender and the Hookah preparer. The bartender told Officer Saucier that she was unaware that patrons could not remain on the premises after 2:00 a.m. and was sorry. The manager also informed Officer Saucier that the manager was in California and that she and the Hookah preparer were in charge.

Ms. Melkonian stated she was in California at time of incident but the bartender had called and informed her and told her that a customer had lost a watch and went to go look for it and his friends were waiting for him to come back when the officer came in.

Ms. Melkonian stated that she had instructed staff that everyone needs to be off the premises by 2:00 a.m. and had subsequently fired the bartender due to this incident.

Upon a roll call the Commission voted 3-0 that the violations had occurred.

Upon a roll call the Commission voted 3-0 to issue a warning.

12. Kirsch Liquors, 646 Main Street – Violation of Rules #6, #21

Robert Kirsch to answer to the violation and waived his right to counsel.

Lt. Johnson presented the following:

On May 25, 2013, Officers Mark Jolin and Bill Stout, along with Lieutenant James Johnson conducted compliance checks at various package stores throughout the city. An underage male (identifying information held at the Worcester Police Station Alcohol Unit) accompanied the officers and was instructed to enter a package store and attempt to purchase alcohol without providing identification. He was instructed to politely state he did not have identification if asked. He was instructed not to be confrontational at any time and to walk out of the place of business calmly with or without making a purchase. He was given these instructions each time he entered a different store and he was observed both entering and exiting the stores. Prior to going out, the underage male was given a breathalyzer test in the cell room and again upon his return. He was not allowed to carry identification on his person.

At around 4:05 p.m., the underage male entered Kirsch Liquors, located at 646 Main Street, and purchased a 40 ounce Miller High Life Beer for \$2.55 without being asked to provide identification. At the conclusion of the sting, Officer Jolin contacted the business to inform them of the violation and advised that the manager would have to appear before the License Commission.

Mr. Kirsch stated he had video surveillance in his store and his clerk had a lapse in judgment when he sold to the minor and his staff has always been instructed to check ID's and he has invested in an ID checker.

Commissioner Mullan note that the staff still needs to use the machine to check ID's in order for it to be effective and he noted that the establishment has not had an incident in fourteen years.

Upon a roll call the Commission voted 3-0 that the violations had occurred.

Upon a roll call the Commission voted 3-0 to issue a one day suspended suspension.
