Chairman Shea stated on the view Mr. Rianucci had showed an area where they planned to sell CBD on the premises.

Mr. Rianucci stated that there would be no on site consumption for CBD and it would only be a small retail area and the product would be sold in a child proof bag which is very hard to open.

Chairman Shea stated that he didn't want to set a precedent by allowing the sale of CBD and had concern about customers using the product on site.

Ms. Kalkounis stated that the License Commission would not have purview over the CBD retail use and if applicant plans to do that he have to comply with all law regarding the sale of it.

The Commission members and Mr. Rianucci discussed where the outside patio would be located and what time it would operate to. Mr. Rianucci stated that the patio would be open to 2:00 a.m.

The Commissioners stated that they would like to continue the application for two weeks so that the ADA accessibility concerns could be addressed.
