

### Agenda Item:

Due to the lack of clarity, limited locations and schedule, and stark contrast to many cities of similar size I am requesting this commission review the busking fee and policies they recently instated, and to change them to promote equity and encourage busking in the city by removing fees and providing clarity.

Additionally, I would like to bring to your awareness the possibility that it is potentially unconstitutional as currently written.

To resolve all these problems, I recommending that it be replaced with a duplicate of Boston's Rules and Definitions (attached) which provides clarity in the form of examples, specific definitions, and does not charge a prohibitive fee.

### Review of US Rights

The First Amendment states that,

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the government for a redress of grievances."

The Fourteenth Amendment states that,


"No state shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any state deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws."

Goldstein v Town of Nantucket (1979) was a court case in Nantucket, Massachusetts. A professional musician known as the "troubadour of Nantucket", claimed that the Town of Nantucket's Vendor Bylaw deprived him of rights secured by the first amendment. Goldstein plays the hammer dulcimer and sings, puts open dulcimer case so that passersby's can contribute to donations. Local businesses had complained about the competition from street artists. In response, the Town of Nantucket tried to regulate buskers as vendors. The board advised him that the new Transit Vendor Bylaw did not apply to him and that he would have to obtain a permit before he would be allowed to proceed further with playing his music. The bylaw defined vendors to include any person who engages in temporary business, dwelling, offering or providing entertainment.

Goldstein argued that due to the first amendment, the regulation included impermissible criteria for regulation of free expression. The requirement of merchants' approval is irreconcilable with freedom of expression. It is unqualified censorship and forbidden according to the First amendment. This case was important because a law cannot be enforced that goes against the first amendment and impedes on freedom of expression. This busker knew his rights and was able to remove the bylaw from Nantucket after winning the case.

Davenport v Alexandria was a court case in 1983 in Alexandria, Virginia. A street musician named Lee Davenport was challenging the constitutionality of Ordinance No. 2609 which prohibits performances and exhibitions on the sidewalks, walkways or other public property of the central business district of Alexandria. Davenport claimed that this infringed on his First Amendment right to perform with, and lecture about, bagpipes. On this appeal, the City concluded that the district court's legal conclusions were erroneous and that there was no legitimacy to the city's allegations of safety issues that were alleged to be related to busking. This case made it possible to refute claims that there were safety issues connected with busking in public places such as Alexandria, Virginia.

Friedrich v Chicago was a court case in 1985 that dealt with busking restrictions in certain areas in the city of Chicago. A class of street performers sued the City of Chicago and challenged the constitutionality of an ordinance with claims that performers are not allowed to entertain pedestrians on Chicago's sidewalks. The buskers claim violations of their First Amendment rights of expression and also the Fourteenth amendment rights to equal protection of the laws.

I wrote a letter to the editor at T&G, and I had a phone call with a reporter, who also spoke with another musician (and possibly more that I'm not aware of).

Next, I talked with that musician as well, and here's a brief snippet of my comments...

Yes! Everything you've said, you nailed it!

So, as of right now, the parks department is mainly putting this into place at parks, Elm, Institute, etc. from April to October. But to me, that's not the point.

I see this as testing the waters, or just, the tip. It's the president that it sets....

If officials - city suits see people accepting this, then that's a gateway to City Hall putting this into action at the baseball stadium, nearby DCU during a big event, on the common / City Hall main street, or behind it, essentially wherever there's high foot traffic.

I too, want to know why this was initiated, WHO does it benefit? Where is the money coing to? Because it certainly doesn't benefit the artists and musicians nor us, the city residents.

Fremember when we had breakdancers up on Main South sometimes, guitarists and singers on Main downtown, and even Park Ave now and again.

But we rarely, if at all, had buskers at the parks. Sure, occasionally, a musician might sit on the bench (on Russell Street) at Elm Park, but it was more for enjoyment than bringing in money. Although, someone may just drop a bill in the guitar case here and there, but that wasn't the primary

Lastly, at one point there were some conversations along the lines of creating a group (artists, musicians and vendors I believe) who would pay in and "rent" ground space to busk at, and some of the greas mentioned were NOT at parks. So let's keep pushing to remove the busking fee no matter where it's currently placed in the city!



### STREET PERFORMERS IN PUBLIC AREAS

The City does not require or issue permits for street performers in public areas.

Street performers are permitted to engage in performances as long as they do not violate any City laws, statutes, or ordinances. Performers may ask for and accept contributions of money or property at a performance. Performers may also sell recordings of their own performances.

### **RULES AND DEFINITIONS**

### STREET PERFORMERS MUST OBEY ALL CITY LAWS AND ORDINANCES

For example, street performers have to follow the City's noise ordinance and the laws against disorderly persons and conduct. Street performers must not block:

- handicap ramps
- doorways, or
- emergency safety equipment.

Street performers also can't block the passage of the public through a public area.

Sometimes, a crowd watching a performance may block the public way. If that happens, a local officer or park ranger can disperse the part of the crowd blocking the public way. They will not move a performer unless the performance affects public safety and order. For example, street performers may not force pedestrians to walk into the street.

Street performers can't produce unreasonable noise and exceed noise levels of 70 decibels at any time. They also may not exceed 50 decibels between the hours of H p.m. and 7 a m, per the City's noise ordinance.

### DEFINITION OF 'STREET PERFORMERS' AND 'PUBLIC AREAS'

\*Street performers\* are also known as 
"buskers.\* They include people engaged in 
but not limited to:

- playing musical instruments
- dancing, acting, and singing
- pantonime, juggling, magic, and puppetry, and
- · drawing, painting, and reciting-







### PERMIT APPLICATION FEE REVIEW

- · Discounts do not apply for staff cost for Non-profit or For- profit organizations
- Discounts may apply for Non-profit organizations that submit their 501C3 Application
- \$125.00 non-refundable down payment will be required at the time of request
- Electrical Fee: \$30.00 per hour. If a staff electrician is needed the fee will be an additional \$60.00/HR with a minimum of 4 hours (the discounts for staff sees)

#### Resident Permit Fee Starts at \$365.00

(\$125 down payment & \$240.00/Park Staff)

#### Non-Resident Fee Starts at \$490.00

(\$250.00 down payment & \$240.00/Park Staff)

## **DPW & PARKS DIVISION STAFF FEES**

- \$60.00 per hour for staff minimum 4 hours per staff
- Electrical Fee: \$30.00 per hour. If a staff electrician is needed the fee will be an additional \$60.00/HR with a minimum of 4 hours
- Portable Stage: Stage is not accessible. Stage Size is 24' (L) x 24' (D) x 4' (H) Stage Fee: \$960.00 for setup & breakdown (No loss waived for staff or Portable Stage)

#### Trash Removal & Disposal

- The trash removal and disposal fee will start at \$400.00 and will increase based on the size of the tournament. This fee does not include facility clean-up
- An additional minimum fee of \$240.00 will be charge for City staff to pickup trash throughout the facility depending on event size
- Additional fees will apply if trash is left behind and not removed from the park if you specified on the permit, you were removing your own trash
- It is the responsibility of the organizations/individual holding the park permit to ensure the facility is clean and presentable at all times

# PERMIT PAYMENTS OPTIONS

#### **PAYMENTS**

The Parks Administration Office accepts checks, money orders, and credit cards. (NO CASH) Credit Card payments can be made by phone or online.

#### **BALANCES**

Any remaining balances must be paid in full before any new park permits will be issued. Also, if you/organization had a remaining balance both the balance and new permit invoice must be paid in full.

# The City of WORCESTER CANCELLATION POLICY

- A 24-hour written cancellation notice (email acceptable) is required to avoid additional fees. A \$125.00 or 10% of the total fee whichever is higher will be charged for cancellations and must be confirmed/approved by the DPW & PARKS DIVISION STAFF
- All weekend/holiday cancellations must be received by 10:00 AM on the last business day prior to your event and must be confirmed/approved by the DPW & PARKS DIVISION STAFF
- Confirmation/Approval is deemed confirmed when the event representative receives a written confirmation from the Parks Division Administrative Office.
   Refunds will not be given to anyone who does not follow the cancellation policy
- A rain date will be given at the time of request not after and it will only be honored if cancelled and rescheduled in time




# **EVENT PARKING PLAN**

It is the responsibility of the organization/individual holding the park permit to address this issue (if any) with all participants, spectators and staffing.

A parking plan will be required with your permit application.



- Vehicles are prohibited in any/all open spaces (grass areas), pedestrian or maintenance pathways and sidewalks
- Vehicles are prohibited from parking along park roadways or other locations identified as no parking areas

# **FACILITY REQUEST**

#### ELECTRIC:

 All request for electricity use must be specific in nature (What will it be used for) not all facilities have access to electricity

#### FOOD:

Food permit is required through the Department of Public Health

#### PORTABLE RESTROOMS:

- Accessible Portable Restroom there must be a minimum of 1 (one), or 5% of the total number of portable restrooms provided
- Accessible Portable Restroom a minimum of 1 (ADA) accessible unit is required at each cluster (when more then one cluster is available)
- Accessible Portable Restroom must be placed off an accessible surface for ease of use

# DPW & PARKS DIVISION POLICY

- EVENT SET UP & BREAKDOWN: City staff are required to be on site for event setup and breakdown. Do not start until staff are on site
- ACCESSIBLE ROUTES: All events must have accessible routes of at least 36" in width along paths of travel
- ADA ACCOMMODATION, THE WORCESTER ADA COORDINATOR: (508) 799-8483





### **DPW & PARKS DIVISION POLICY**

- Inflatable's: (No Stakes) Alternatives: Sandbags, water weights, etc.
- <u>Tents</u>: (No Stakes) Tents larger than 20 x 20 may require a permit, please check with the Inspectional Services Department
- Alcoholic Beverages: All alcoholic beverages as defined in Chapter 138 Section 1 of MGL are prohibited (Worcester Common can be petitioned) No smoking in Parks (That includes E- Cigarettes, any form of tobacco products including chewing tobacco and marijuana)
- No dogs on the Worcester Common, Athletic Fields, Athletic Courts, Playgrounds, Skate Parks, Pools, Spray Parks and beaches (Memorial Day to Labor Day)
- Dogs are allowed in City Parks on leashes only. Dogs are allowed on beaches from Labor Day to Memorial Day
- No drones or radio control aircraft (land, air, or water) allowed in Parks (Refer to Federal Aviation Administration Regulations FAA)

# GOOD NEIGHBOR PRACTICES

- WORCESTER SOUND ORDINANCE: Any amplified sound shall not be plainly audible at a distance of 50 feet or more from said public park, playground, and playing field (City of Worcester Ordinance Chapter 9-Sec 1A)
- A permit will be required for amplified sound from the Worcester Police
  Department at (508) 799-8686 (Information List on Parks Application (Permits)
- Water Supply Alert: There is no current Alert but depending on weather one can be implemented at any time

## PERMIT REMINDERS



- Facility availability will not be given over the phone or via email
- All 501C3 non-profit requests will be completed before any other permit request
- Parks & Recreation Commission (Policies & Regulations)
- Permit application address (Use an address where mail is check regularly)
- Permits will only be given between the hours of 9:00 AM to 3:30 PM (Monday-Friday- Excluding Holidays)
